ROLL-OFF DUMPSTER RENTAL AGREEMENT

Terms & Conditions:

I, _____ (Customer requesting service) agree to the following terms and conditions for rental of described services.

Pricing & Payments:

1. Customer agrees to pay _____ (STANDARD RATE) for _____. Container which includes up to **6 tons** of materials for 30yd and 40yd. Due to strict DOT (Depart. Of Transportation) weight restrictions and associated environmental fees, any overages or overfill will be billed at **\$85** per ton above **6 tons**.
2. Customer agrees to pay **\$95** one-time delivery fee plus fuel surcharge.
3. Standard Rate includes use for up to **14 days**. If the dumpster is kept longer there will be an additional **\$10.00 Inactivity fee Per day**. "Agreement may be cancelled with a "30 Day Notice" in writing ."
4. Mattress, couches, appliances, tires, televisions, computer monitors, white goods, non-friable asbestos, telephone poles, railroad ties, and agricultural waste are subject to additional charges. Fees range from \$5 to \$250 per item.
5. Balances are subject to 1.5% charges (per month) on any outstanding balance if not received according to terms.

Dumpster Use:

1. Customer shall be liable for any loss or damage to rented equipment.
2. Customer is responsible for filling the dumpster, loaded evenly and level -nothing should extend higher than the sides or top rails. If over loaded the driver will remove the excess materials and place them on the ground, the driver "will not" reload the materials."
3. Customer acknowledges to care for the rental and the contents of the container. Customer will indemnify and hold harmless Tri County Hauling & Demolition of any damage or injury to persons or property while the container is in customer's possession until the contents are disposed of.

Access and Ground Conditions:

1. The customer will be responsible for the provision of free and suitable access to and from the delivery site (including the removal and reinstatement of local obstructions) and for insuring suitable ground conditions for delivery, placement and removal of the dumpster.

2. No responsibility will be accepted for the damage to any surface, and you should therefore take steps to protect surfaces (e.g., paving, slabs, soft ground, sod, lawn, asphalt, landscaping, overhead obstructions, etc.) before delivering.
3. If the property is damaged due to the negligence of Tri-County we will be responsible for the repair.
